

Coordination could be performed in a permanent Activity Group Flight Standards AG

Flight Standards are

- Regulated in Regulations Aircrew and Air Operations across the Communities CA, GA, R and D and relevant for the Sectors and Technologies
- Rulemaking and Standardisation levels to be discussed, developed and followed up in <u>ONE</u> permanent Activity Group (AG)
- Sustainability and Digitalization are good examples for issues the require coordination efforts
- Flight Standards AG is in line with RoP v2022 Article 12 as it is

"of particular importance for the performance of cross-domain work"



Flight Standards Activity Group - Mandate

- Coordinate and conduct bi-annual joint meetings between Aircrew TeB, EASA, EC and Aircrew Experts from the new Communities to enable further improvements in standardization of NAAs (e.g. Examiner Difference Document)
- Promote similar joint meetings between Air Operations TeB, EASA, EC and Air Operations Experts from the new Communities
- Monitor progress of active Rulemaking tasks related to Regulations Aircrew and Air Operations (e.g. RMT.0194 (Instructors), 0196 (FSTDs), 0737 (electr. LIC)....) and coordinate information flow into and between the new Communities
- Coordinate digitalization projects with relevance for Regulations Aircrew and Air Operations with new Communities (e.g. RMT.0737)
- Support transition from Inventory based regulation towards Performance based regulation of Regulations Aircrew and Air Operations

Flight Standards Activity Group - Tasks

- Coordinate Aircrew and Air Operations related issues between all sectors
- Clarify issues within the given framework (FAQ, AMC, GM, Policy, etc.) and escalate to Rulemaking only when necessary
- Assure consistency of application across the EU and the sectors of the communities
- Future proof the Regulations to the developing technologies across all communities
- Support pan-European interpretation of the applicable Flight Standards Regulations
- Interface with Training Activity Group
 - Coordinate with Training Activity Group concerning amendments of Regulations Aircrew and Air Operations


